Agenda:

1. The meeting was called to order at 6:19 p.m.
2. This special meeting was called to make progress more quickly on the Teen Safe Night.
3. Thiersten and Cindy reported that they both had no luck reaching staff of community centers and Cal Expo. Joe also left a message with Erica Emanuel from Cal Expo but she had not yet returned his call. Joe reported that the Redwood Room at CSUS is not available until 9:00 p.m. on June 18th. The Commission decided that that 9:00 p.m. was too late to begin the event. However, the CSUS Alumni Center is available on June 11th, June 25th, and July 16th. Joe reserved the Center for June 25th in case the Commission could not find any other location. The rental fee is \$1,000 for 8 hours plus a \$250 security deposit and liability

insurance (cost not yet known). The Alumni Center has a kitchen (with refrigerator), an ice maker, and they allow catered platters but not homemade dishes. They also will allow the Commission to bring in a virgin margarita making machine. The facility can hold up to 400 people. The reservation can be held for one week before 50% of the payment is due. The Commission voted unanimously to change the event date to Saturday, June 25, 2005 and to rent the CSUS Alumni Center for the event. Joe will call the Alumni Center to schedule a site visit of the facility on Friday, April 1st at 4:00 p.m. Several commissioners will visit the facility with Joe.

4. The advertising subcommittee could not find any radio station willing to come to the Teen Safe Night. However, they will call the radio stations back to see if any of them are available on the new date of June 25. Thiersten also recommended contacting News 10 because they are very willing to do community stories.
5. Rachel talked to the professional decorator who is willing to work within our budget. She will ask if he is available for June 25th. If he is unavailable or if he charges too much, the Commission can decorate the hall on their own. Rachel reported that Wishing Well had a lot of decorations and supplies that could be used for the Teen Sate Night. The Commission suggested that Rachel check with the decorator to see how much could be done with \$300. She will also check a distribution center and Costco for margarita mix.
6. Cindy will check with her friend, Colby, to see if he can DJ. If not, Thiersten said her dad would be willing to DJ for free.
7. The Commission will charge \$3 for admission (includes one free virgin margarita).
8. Wristbands can be ordered from reminderband.com for \$1.50 each. In order to qualify for this price, a minimum order of 260 is required. The Commission will order the minimum amount. Thiersten will do further research.
9. The meeting was adjourned early at 7:10 p.m.
