### 3. Approve Minutes of August 18, 2008 Meeting

- Michele is going to email the survey out to the commissioners in order to discuss how the survey could be shortened so that people would finish it.
- We could possibly get a consultant to conduct the survey. But we are not sure how much this would cost and if we could spend the money.
- Harjot and Megan agree to shorten the survey where necessary.
- Naomi would like to research the cost of hiring a consultant.
- Michele suggests that we look into having CSUS students help us administer the survey.

#### **7. Trade Schools Brochure Project Update**

- Naomi never got an email so she did not have a chance to update the brochure.
- Michele will resend the email.
- There will be a new draft by the next meeting.

#### **8. Transportation Safety Brochure: Continued Discussion**

- Sacramento Regional Transit has a teen-friendly website, but Youth Commission could help promote the site.
- One idea is to make a flyer about regional transit and brief safety tips to put in schools and counseling offices.
- Sylvia suggested a link on the Youth Commission website to a new site put together by the youth commissioners about public transportation and safety
- Naomi would like the website to be more "friendly."
- Michele will check with the county IT department to see if they would be willing to redesign the website. Perhaps they could come to the next meeting to discuss the different possibilities.
- Megan suggested that we see how many hits the new website gets before putting out paper fliers or posters.
- Overall, the website needs to be made friendlier.
