- 1) Welcome & Introductions:
  - a. Commissioners introduced themselves and welcomed Renae McClain-White to the commission.
  
- 2) Approve Minutes:
  - a. On a motion by Commissioner Hailee Makin, seconded by Commissioner Vishruth Nagam, the February 1, 2021 meeting minutes, as revised, were unanimously approved by those members present.

- 3) Sacramento County District Events
  - a. District 3: Commissioner Hailee Makin announced the Mental Health and Wellness Workshop held by the City of Sacramento Youth, Parks, and Community Enrichment. The workshop is being held via zoom throughout the month of March.
  - b. District 5: Commissioner Elyssa Tse announced the Franklin High School Children's Theatre is holding online musicals between March 5- 19.
  
- 4) Review Of Board Of Supervisors Agendas And News Articles:
  - a. Commissioner Hailee Makin presented the Board of Supervisors meeting on February 9, 2021 and March 9, 2021. The Board considered nominations for the Children's Coalition and the Sacramento County Youth Commission.
  - b. Commissioner Lauren Williams volunteered for the April meeting.
  
- 5) Subcommittee Updates:
  - a. Distracted Driving Subcommittee
    - i. Co-chairs Commissioner Kate Saunders and Commissioner Hailee Makin provided an overview of the subcommittee and talked about conducting a workshop to develop more ideas and creating posters to spread awareness about this mission.
  - b. Environmental Care Subcommittee
    - i. Co-Chair Commissioner Ema Dang presented that the subcommittee are considering a weeklong Earth Day event that would bring awareness to the day and the meaning behind it. She also discussed scheduling more subcommittee meetings.
  - c. Mental Health Subcommittee
    - i. Co-chair Commissioner Ashley Jun presented an overview of the subcommittee as they hope to further grow the partnership with the Miracle Friends Organization.
  - d. Voter Pre-registration Subcommittee
    - i. Co-chair Commissioner Eleanor Love presented the overview of the subcommittee. The subcommittee has been working on contacting local school districts within and around the Sacramento community, specifically contacting

the Communication Director's for the Elk Grove, San Juan and Sacramento City school districts.
