- 1) Welcome & Introductions:
  - a. Commissioners welcomed each other, introduced themselves, and began the meeting.
  - b. Interim Advisor Alma Munoz and Jillian Myers, the youth commission's new advisor, introduced themselves.
  
- 2) Approve Minutes:
  - a. On a motion by Commissioner Hailee Makin, seconded by Commissioner Vishruth Nagam, the April 19, 2021 meeting minutes, as revised, were unanimously approved by those members present.

- 3) Appointments From Your Own Ranks to the Sacramento County Commission on the Status of Women and Girls (Action Item)
  - a. Interim Advisor Alma Munoz introduced the formation of the Commission on the Status of Women and Girls. As well as the consideration of the Youth Commission's own appointment to the new commission.
  - b. Commissioners Hailee Makin and Kate Saunders expressed interest in joining the Youth Commission.
  - c. Item is to be continued to the June meeting and possibly further down the calendar, depending on when the commission is formally created.
  - d. Action Item motioned by Commissioner Ema Dang and seconded by Commissioner Elyssa Tse.
  - e. All commissioners voted in favor of continuing the discussion of the new commission.
  
- 4) Sacramento County District Events
  - a. There are no District Events this month.
  
- 5) Review Of Board Of Supervisors Agendas And News Articles:
  - a. Commissioner Kayli Huang presented the April 14<sup>th</sup> Meeting, where the requested base budget for the Child, Family, and Adult services was reduced by \$937,000 to provide for the Dine at Home Sacramento program.
  - b. At the April 6<sup>th</sup> meeting the board considered nominations to the Maternal, Child and Adolescent Health Advisory Boards.
  - c. Commissioner Huang also presented the April 20<sup>th</sup> meeting in which \$672,000 was passed for home-based shelter care services for children in out-of-home placement. They also allocated money from the California Department of Social Services to support COVID-19 related activities for children and families.
  - d. The board also recognized April 2021 as Child Abuse Prevention Month.
  - e. Board members also considered nominations for the Children's Coalition, and the Sacramento County Commission on the Status of Women and Girls. They will also be considering the Youth Advisory Board and they will be voting on the ordinance tomorrow, May 18, 2021.
  - f. Commissioner Kate Saunders volunteered for the June meeting.

- 6) Subcommittee Updates:
  - a. Distracted Driving Subcommittee
    - i. Co-chair Commissioner Kate Saunders discussed continued brainstorming for the subcommittee, possible connections with California Highway Patrol, CHP, and other possible organizations to collaborate with.
  - b. Environmental Care Subcommittee
    - i. Co-Chairs Commissioner Katie Huh and Ema Dang presented their continual plan of utilizing social media to spread awareness.
    - ii. Commissioner Ema Dang also proposed planning for TED's Countdown events on spreading awareness and proposing climate solutions.
  - c. Mental Health Subcommittee
    - i. Co-chair Commissioner Ashley Jun discuss working with the Miracle Friends Organization.
  - d. Voter Pre-registration Subcommittee
    - i. Co-chair Commissioner Eleanor Love presented the ongoing progress of High school voter registration week. The subcommittee has been working with San Juan Unified School District as well as the Elk Grove Unified School District. They are currently sending information to those districts to be spread to their high schools.
    - ii. The subcommittee is also in contact with Courtney Bailey to help educate Sacramento County's Youth.
  - e. Board of Supervisors Presentations Subcommittee
    - i. Interim Advisor Alma Munoz help guide commissioners in making the final edits of their presentation.

## Announcement Youth Applicants

### SACRAMENTO COUNTY COMMISSION ON THE STATUS OF WOMEN AND GIRLS

The Sacramento County Commission on the Status of Women and Girls is a new county commission established to advise the Board of Supervisors and the public on policy and planning around issues affecting women and girls in Sacramento County. The Commission will serve as a resource to advance gender equity, justice, and well-being for all women and girls in Sacramento County.

Based on the recommendations of the Blue Ribbon Commission on the Establishment of a Sacramento County Women's Commission presented to the Sacramento County Board of Supervisors in December, 2020, the Commission will be comprised of **FIFTEEN** seats to be filled as follows:\*

#### **FIVE seats to be filled by residents of the area as follows:**

- ONE resident of District 1 (District 1 nomination) to serve initial two year term,
- ONE resident of District 2 (District 2 nomination) to serve initial two year term,
- ONE resident of District 3 (District 3 nomination) to serve initial two year term,
- ONE resident of District 4 (District 4 nomination) to serve initial two year term,
- ONE resident of District 5 (District 5 nomination) to serve initial two year term

**(District Representative seats are for two terms max, subsequent terms to be three years)**

#### **THREE seats to be filled by Youth:**

- ONE person (age 14-18, who is a current member of Sacramento County Youth Commission) to serve initial one year term
- ONE person (age 14-18), to serve initial one year term
- ONE person (age 18-21), to serve initial one year term

**(Youth seats are for two terms max, subsequent term to be one year)**

#### **SEVEN At-Large seats to be filled:**

- ONE person to serve initial three year term
- ONE person to serve initial three year term
- ONE person to serve initial three year term
- ONE person to serve initial one year term
- ONE person to serve initial one year term
- ONE person to serve initial one year term
- ONE person to serve initial one year term

**(At-Large seats are for two terms max, subsequent terms to be three years).**

\* Commissioner terms will be staggered at first. In the first year of the commission, four members will be given a one-year term, five a two-year term, and three a three-year term. All terms will be three years thereafter, to maintain continuity.

The application filing period will be from **03/23/2021** to **04/14/2021**. Applications for the FIVE District and THREE Youth seats will be reviewed by the Board of Supervisors.
